Chad went through a timeline of events that day for those assembled. There were a variety of questions asked and answered as the discussion went on. There was also a list of action items that were developed in response.

- Call Emergency Management for events of this nature to help get notifications out to the public more quickly.
- Develop a reporting mechanism.
- Ask Iowa Association of Municipal Utilities if they have a template already available for a reporting mechanism.
- Add the Fire Department to our call list in cases where available fire flow is diminished.
- Check with the Iowa DNR for additional public notice procedures and add an emergency notification number to our call list for the Iowa DNR field office 5.
- Develop a list of critical processes and the necessary procedures to follow in the event of a failure in any of these processes.
- Use the list of critical processes and develop a procedure for monitoring and recording of these processes.
- Develop a written procedure that identifies what to do in crisis management and have that document reviewed by different agencies and departments in Oskaloosa.

• Include Fire, Mahaska County EMA, and the Board of Health in notifications and action plan.

Chad was directed to have these items completed by May 9th in draft form and then be ready with a presentation for the May 16th regular Board of Trustees' meeting.

The next agenda item was miscellaneous. Chad was instructed to add a standing item for 28E progress discussion to all future Board meeting agendas.

There being no further items to discuss, it was moved by Kevin Tacke, and second by Brad Hodges to adjourn.
